CLASSIFICATION OF GOLF MEMBERSHIP

A membership at Ashland Golf Club permits the member to use the facilities of the club in accordance with the classification of membership selected by the member upon payment of the individual level of dues.

Full Golf Membership - Family or Single

A <u>full family golf membership</u> permits the member and their immediate family to the use of the golf course, practice areas, clubhouse and attend member-sponsored events at the club. Immediate family includes the spouse of a member living in the member's home and unmarried children no older than 21 either living in the member's home or attending school on a full-time basis. A <u>full single golf membership</u> permits only the member to receive unlimited use of the golf course, practice facility, and clubhouse and attend member-sponsored events at the club.

Junior Golf Membership - Family or Single

A <u>junior golf membership</u> is available to persons 35 years of age or younger. A junior membership will have all the same rights as a full golf membership. Upon exceeding the age of 35 the annual dues will increase to those of a full golf membership classification.

Weekday Golf Membership - Family or Single

A <u>weekday golf membership</u> permits the member golfing privileges at the golf course, practice areas, clubhouse and attend membersponsored events.

Youth Golf Membership (summer pass)

Available to approved individuals who are active students under the age of 21 seeking full golf privileges at Ashland Golf Club. Summer pass is valid from Memorial Day-Labor Day. Season pass includes unlimited golf. Cart fees are not included. Youth memberships are designated as 16 and under, and 17-21.

2024 Golf Cart Lease Agreement

Member(s) acknowledges and agrees to the following:

Membership Program Summary (1/1/2024

- 1.) All Cart Trail Fees purchased from the club are applicable to those on the membership only.
- 2.) All private carts stored on the property are for use of those on the membership only. Other riders will be charged appropriately if they choose to ride the privately-owned cart.
- 3.) All maintenance of privately-owned carts will be at the expense of the owner as Ashland Golf Club will not be held liable for damage due to negligence or weather.
- 4.) No more than 2 persons and 2 golf bags may occupy a cart at any time.
- 5.) Guests or members may ride in a private cart provided they have paid the appropriate daily cart fee, guest fee, or are a current cart lease holder. Appropriate fees will be billed to the member account if check-in has not been completed.
- 6.) Members shall drive in a responsible manner, observing all the rules and regulations, which include driving no closer than 30 feet to any green, hazard, water or ground under repair, and must obey cart signs and weather-related rules.
- 7.) Any property damage or physical injury caused to or by the cart while it is in the care, custody and control of the operator shall be the responsibility of the operator. The cart lease holder hereby agrees to indemnify the Ashland Golf Club and hold them harmless of any and all liability.
